

Two 765 kV transmission lines are proposed through your constituents' land.

MariBell and BECI are two separate projects with separate developers, routes, and filing dates. Both are part of MISO's Long-Range Transmission Plan (Tranche 2.1, approved December 2024). Both would cross the Driftless region on steel towers 150–200 feet tall, and Wisconsin ratepayers would help pay for both.

WHAT YOUR BOARD SHOULD KNOW

- The permit decision rests with the **Public Service Commission of Wisconsin** in a CPCN proceeding. Local governments do not issue the permit — but resolutions put a community's questions and position on the public record.
- State policy directs that, to the greatest extent feasible, **existing utility corridors** be used first in siting new lines.

- New 765 kV corridors can require rights-of-way up to **250 feet wide**; existing local transmission easements are roughly 70 feet.

- BECI comments on study segments close **September 7, 2026**; with a February 2027 filing, the public phase is about seven months. Prior Wisconsin proposals allowed two years or more.

WHAT COMMUNITIES HAVE DONE

19 Wisconsin local governments and public bodies — counties, cities, towns, villages, and a state reserve board — were on record by late August 2026, through information-request resolutions and resolutions of opposition. Signed copies are posted publicly.
